Started doing flu immunizations at both Menard and Sangamon Clinics, as well as outbound in Sangamon and Menard Counties.

VI. Health Department services hours in Menard County:

Gail reported last week 16 people received immunizations at the Menard Clinic. Pre-COVID we did half days on Tuesdays and Thursday providing immunizations and WIC. Advertisement was put in the Menard papers. WIC program is still in an Emergency Status, therefore their appointments can be completed by phone. At this time services are being provided on Thursday mornings at the Menard Clinic.

Gail reported at this time all restaurants are doing well now. There has been some issues with a popcorn vendor at a fair in Menard County, and it is being handled.
